



## **2012-13 Advanced Akashic Studies Practitioner Program with Teacher Certification Option**

### **“Discover Leadership Through Your Akashic Records” Program Details**

We are in the foothills of a glorious spiritual revolution! Each of us has a role to play in its unfolding. If you have a sense that there is more for you to contribute to life, consider this training. If you have been wondering how you can give more and in ways that nurture and sustain you, I invite you to consider this training. If you are curious to explore your unique gifts, talents and abilities and their usefulness in life, join us in these spiritual waters - dive in! This course will provide a safe, powerful space for you to awaken to the realities of what you have to offer. Navigate your personal healing and transformation. Transcend your limitations. Live an ascendant life!

This intensive course provides a structure through which you can discover how much good can come through you as a result of your relationship with your Akashic Records. This is a place to wholeheartedly pledge your talents and experience to this amazing work. Join fellow travelers sharing a similar level of commitment, dedication and enthusiasm move toward the Light through the Akasha. Ours is a spiritual journey on a human path with benefits on every level. Encounter spiritual wisdom and power. Become adept at the best and right uses of the Akashic Records. Magnetize what is yours. Radiate your essential goodness. Become a greater blessing to your loved ones.

During our time together, we will travel a complete and thorough spiritual curriculum for your personal development and empowerment. This program has been revealed to me through my own relationship with my Records to be shared with others. My priority is for you to cultivate an awareness of your unshakable connection with your soul and the infinite spiritual resource of the Akashic Records. Your expanded awareness will give you access to the profound riches of the Akasha for healing and transformation.

The Advanced Practitioner Program has two components. The first is for those seeking their own personal progress, which includes all of us! As well as those seeking to master Pathway Prayer Process skills for themselves and others, whether using the Records as a stand-alone infinite spiritual resource or in conjunction with another system. Completion of this program entitles you to an Advanced Practitioner Certification, which is required to continue on the Path



of the Program to the Teacher Training segment. A CAS Teacher Certification is awarded to those students successfully completing their practicum within one year (by January 31, 2014). This practicum includes hosting a Beginning Certification Class with One Day Foundation Class to be taught by one of certain designated CAS Certified Teachers or Linda Howe herself. A CAS Teacher Certification qualifies you to teach the Beginning Certification Class along with the three Foundation Classes (Energy Healing Through the Akashic Records, Clearing Unwanted Ancestral Patterns and Past Lives as presented in *How to Read the Akashic Records* by Linda Howe).

Prior to beginning this journey, read Linda Howe's books *How to Read the Akashic Records* and *Healing Through the Akashic Records*, and listen to the CD sets of the same names. We also recommend you listen to the mp3 recordings of classes offered by Linda Howe found on her website. To satisfy the requirements for certification, you must attend each of three Core Akashic Records Classes (Beginning Practitioner Certification, Healing Through the Akashic Records, and ExtraOrdinary Life), which will be taught by Linda Howe or in the case of the Beginning Class only, one of certain designated CAS Certified Teachers at various U.S. locations over the course of the next 12 months. (Note: Akashic Records classes taught by anyone else under any other program will not be given credit in this program.) In addition, listen to four podcasts, perform a minimum of 30 Akashic Record Readings and submit evaluations of same, set up a book study group, "meet-up" group or other similar gathering in your community that is specifically focused on discussing and practicing Akashic Records as taught by Linda Howe. Finally, a private Facebook group will be established for all of those enrolled in this program to provide a place where you can interact with your fellow students.

The final stage of the training program, which is mandatory for all students, is a weeklong intensive program held in Chicago in January 2013.

**Registration:**

The total cost for this intensive, unique, transformational program is **\$2,000** (early registration incentives could reduce this to \$1,700). Because there are a limited number of spaces, only serious, committed students should apply. We have done our best to estimate costs and time commitments required. Each student approaches the work differently, and so consider these estimates to be minimum investments.



### Non-refundable Registration Deposits

- \$600 to be paid by September 1, 2012, or
- \$500 if paid before June 1, 2012 (\$100 early registration discount)

### Registration

To register for the mandatory weeklong intensive program held in Chicago, students must provide CAS with all of the following by September 1, 2012: proof of completion (or evidence of registration) for all three Core Akashic Records Classes (Beginning, Healing and ExtraOrdinary Life), a completed written application, and payment of the non-refundable deposit.

Upon receipt, applications will be reviewed and verified by CAS, and if deemed satisfactory and complete, an hour-long telephone interview with Linda Howe shall be scheduled to discuss and assess candidacy as well as strategize a viable plan for success. Subsequent to a successful telephone interview, written acceptance into the Program shall be delivered, at which time the balance of the registration fee shall become due.

### Payment of Balance

- \$1400 due no later than December 15, 2012, or
- \$1200 if paid before October 1, 2012 (\$200 early registration discount)

Please note: These fees do not include: the costs of the Core Akashic Records Classes, accommodations, travel, food or other incidentals. If space permits, late registrations may be accepted, however, additional fees will be applied.

### No Refunds Policy

Upon written acceptance into this Program, all monies paid to the Linda Howe Center for Akashic Studies become completely non-refundable.

### **Application Process:**

### Content of Application

1. Please write 1-2 typed pages clearly describing:
  - a. why you want to take this Program,
  - b. your current plans for using your Certification,
  - c. why you think you would be a good Advanced Practitioner or Teacher,
  - d. what specific strengths and talents you will bring to your practice of working with others, and
  - e. what your weaknesses may be with respect to this work.
2. Proof of completion or registration for the following in-person classes:
  - a. Beginning Certification Class/Foundation Class with Linda Howe or a designated CAS Certified Teacher, and
  - b. Healing Through the Akashic Records with Linda Howe, and
  - c. ExtraOrdinary Life with Linda Howe.
3. Payment of a non-refundable deposit of \$600 (\$500 if paid before June 1, 2012).
4. Upon written acceptance into the Program, sign and return papers acknowledging and accepting the components and expectations of the Program.

### **Advanced Akashic Studies Practitioner Program**

#### **Part 1 - Core Curriculum**

Complete these three Core Akashic Records Classes in person within 2011-2012:

1. Beginning Practitioner Certification with Linda Howe or a designated CAS Certified Teacher and at least one, One-Day Foundation Class (15 hrs; \$300-\$425) including:
  - Energy Healing through the Records
  - Past Lives
  - Clearing Unwanted Ancestral Patterns
2. Healing Through the Akashic Records weekend class or 5-day retreat with Linda Howe (15-25 hrs; \$425-\$2000), and
3. Your ExtraOrdinary Life weekend class with Linda Howe (12-15 hrs; \$425), for a Total of 42-55 hours (estimated cost \$1100-2850)

**\*NOTE:** Beginning level courses taught by designated CAS Certified Teachers (as listed on the [www.akashicactivities.com](http://www.akashicactivities.com) website) will satisfy the Beginning Class requirement, as will previous certification at Akashic Records Classes taught by Linda Howe in 2011. If you have questions regarding the eligibility of a class, please contact CAS.



## **Part 2 - Independent Study: Reflect and React**

Complete this homework and submit it prior to December 15, 2012:

- **30 Readings** - Readings are the key. Satisfactorily perform at least 30 Akashic Records Readings of clients. Each Reading should last a minimum of 30 minutes and a maximum of 60 minutes (approximately 15-30 hours total). For each Reading, complete a client evaluation on a 3 x 5 index card answering these two questions:
  - What was most helpful to you in this session?
  - What was not helpful to you in this session?

All comments will be anonymous. In addition to client cards, submit a one page self-review of progress doing Readings. Describe how the physical elements (such as time of day, place for meeting, length of session) support the quality of the work. Also reflect on: What readings are easy for me? Which topic areas are more difficult? How has my practice grown over the past few months?

- **Four podcasts** - Listen to four, 45-minute audio mp3 training podcasts (at times convenient to you) and submit one, five-paragraph (one page) reflection and response for all. Each recording addresses topics essential to having a viable practice of working with others, the Inner and Outer Aspects of having a practice, and includes concerns fundamental to the practitioner such as time, money, place, self-care for a Practitioner and maintaining a fit spiritual condition. This is an opportunity for evaluating, correcting and implementing suggestions for your success as well as validating the process through the reporting process.
- **Your Personal Practice** - Practice makes perfect. Practice in your own Records an average of three times per week for approximately 30 minutes per session (1-2 hours per week). Over the timeframe of your participation, record your findings in your Records. Submit a one page assessment of the growth and development in your relationship with your own Records (completed in an ordinary state, not while in your Records). How are you, as a person, tracking your progress? Please answer the following questions: In what particular ways has my connection with my Records grown? How has my receptivity changed? What is the nature of my questions and what is distinct about the changes since joining the Program? What is most impressive to me about the evolution of my relationship with my Records? In which areas would I like to have a stronger connection or greater clarity?



- **“Meet up” or Book Club Study Group** - Connect. Establish and maintain a regular, ongoing connection with a group of people who meet in-person monthly, for a minimum of four sessions, in either format: “meet-up” group or book study group reading *How to Read the Akashic Records*. Arrange a convenient location, invite guests, facilitate each gathering and submit a half-page written report including the location, number of guests, topic, format, what worked/didn’t, what you learned and how you plan to apply your new understanding to your next group meeting. Total due: 4 reports, totaling 2 pages.
- **Light Meditation** - Prepare an original, 10-minute guided meditation to be presented to your peers at the January 2013 class. Work both within your Records and outside of your Records to craft this practice. Submit your meditation outline (no more than one page in length), highlighting entry, core ideas/experiences and exit. This meditation is to be verbal only without props, music, dance or therapeutic practices. This is your opportunity to develop and refine a powerful Light meditation.
- **Personal Introduction** - Tell Your Story. Prepare a 10-minute talk to present to your peers in the January 2013 class. The purpose of this talk is to let us know who you are and describe your personal purpose in this work. The Akashic Records are the story of your soul’s journey through human experience and so it is essential to be aware of your spiritual story and its influence on your human journey, as well as the value of this work in your everyday life. Submit a one page outline of your talk including a compilation of perspectives both within and outside your Records, answering the following questions:
  - How did you find the Pathway Prayer Process? What difference has it made in your life?
  - What do you love about your practice in the Records?
  - Why do you want to share this work with others?
  - What is the practical value of this work in your life?



### Homework Summary

The completed Independent Study/Homework package must be submitted as an attachment to an email before December 15, 2012. The entire packet will be 8 pages plus copies of 3x5 cards representing your Independent Study work over the time of your class participation in 2012 and shall include:

- Readings – copies of 30 client evaluations and one page self evaluation
- Podcast – 4½ page self reflections (total 2 pages) in response to each individual podcast
- Personal Progress in your own Records - One page assessment of your growth in your own Records
- Group Reports - 4½ page review of group meetings and what you learned (total 2 pages)
- Outline for 10 minute Light Meditation - No more than one page
- Outline for 10 minute Personal Introduction - No more than one page

### Part 3 – Weeklong Intensive Workshop

Attend the seven-day workshop taught by Linda Howe from Sunday, January 20 through Saturday, January 26, 2013, at the Carleton Hotel, in Oak Park, Illinois, a pedestrian-friendly urban suburb of Chicago, with many reasonably priced dining/entertainment options. A block of rooms has been reserved at the Carleton at a reduced rate; other housing options are available within walking distance from the hotel and will be noted on the special page designated for this program on the CAS website.

### Part 4 - Teacher Certification Option

After completing all of the above (Parts 1-3), a student may wish to proceed with Certified Teacher certification, upon approval by Linda Howe. In order to obtain Teacher Certification, a student must participate in a Practicum, composed of successfully hosting a Beginning Certification Class with a designated CAS Certified Teacher by January 31, 2014, or by hosting a Beginning Certification Class taught by Linda Howe.

Following completion of the Weeklong Intensive Workshop, students who wish to seek Teacher Certification shall, in addition to having completed all of the Advanced Akashic Studies



Practitioner Program requirements, secure an available location(s) dates, and map out action steps necessary to manifest a Beginning Certification Akashic Records Class to learn how to manage a class.

Certified Teacher candidates may work independently to host a designated CAS Certified Teacher, or with a group (up to three students) to host Linda Howe. Additionally, designated CAS Certified Teachers and students are invited to work together to produce a successful class pursuant to time/money and content requirements as set forth by Linda Howe.

The Teacher Certification Option grants a student the privilege of teaching the Beginning Certification Class and Foundation Classes, essentially the material from *How to Read the Akashic Records*. Eventually, students are encouraged to develop their own work in the Records and to teach that work, however, this certification shall cover only work developed by Linda Howe, which shall be taught according to her curriculum (per outlines provided). Upon certification, no fees shall be charged by CAS to Certified Teachers teaching Linda's work.

Outlines for all materials will be provided to students upon arrival.

**What to expect:**

In our time together, we will participate in a variety of activities including spending time working in our own Records, making note of our experiences, sharing with others one-on-one, in small groups and in the larger community. A portion of our time will be dedicated to giving and receiving Akashic Record readings to our peers. All students will be required to present both their guided meditations and personal stories to the group.

**Standards of Participation:**

1. This is a professional certification program requiring focus, attention and energy. Once accepted into the Program, but prior to Advanced Certification (Practitioner or Teacher) you are not to present yourself as a Certified Teacher until you have actually earned your Certification.



2. We have found that it is counter-productive to participate in more than one Advanced Professional Training at a time. While engaged in this process, for the purpose of discovering the value of this work for yourself and your clients, we ask that you refrain from taking another course of study while in this program.
3. We understand that many of you have achieved mastery in many disciplines and methods. However, as you embark on this path, we encourage you to allow yourself to be a student and let yourself be taught. While you certainly bring much to the group, let yourself learn. Do not deprive yourself the opportunity to be nurtured as you find your way on this remarkable journey.
4. Students must refrain from use of alcohol and recreational drugs 24 hours prior to opening the Records and at all times during classes.
5. This is a class in the practice of spiritual principles. We will work in groups and expect that there will be challenging phases. Please give each other the benefit of the doubt as you walk this path together. In an intense yearlong program such as this, interpersonal relationships developed with fellow travelers create an extremely important component of the total experience. It is our hope and expectation that any conflicts that do arise can be resolved lovingly and respectfully. Conflict resolution begins with consulting your own Records to discover how this particular difficulty is supporting your personal growth. Keep your focus on yourself, considering the issue as an opportunity for you to go further in your own healing. Individual differences are to be expected and will prepare you for the inevitable challenge of working with others in the world who have a variety of personal self-expressions. Taking responsibility for your beliefs and interpretations is a powerful and necessary step in the development of a spiritual leader.

**Facebook Group and Protocol:**

The purpose of the Facebook page is for students to connect with one another, share their experiences using the Pathway Prayer Process, and to support and encourage one another along the way of this profound journey. This is a forum for exchanging positive insights and understandings. Please be aware that this is not a market for the promotion of your personal practice of doing Akashic Record readings or spiritual work of any type. Any student found promoting their personal business (offering your services to another student for a fee) will be banned from the group.



This can be a wonderful arena for connecting with fellow travelers for the purpose of ride-sharing to and from the airport, and the like. Should you choose to use the Facebook group in this way, please know that Linda Howe and CAS take no responsibility for providing personal services such as ride and room connections.

Because of the public nature of this space, do not share phone numbers or other personal contact information with other students under any conditions.
